The above work includes composing, proof reading, processing, plate making, printing, cost of paper, cover design & binding and delivering to the NFCH Office at Lok Nayak Bhawan.


3. Interested firms are requested to submit their quotations separately for each item of work as mentioned above along with requisite documents i.e., registration certificate of firm, PAN Card, GST Registration Certificate, Sample of Papers mentioned in the specifications, Audited Accounts of the firm for last three years, experience to work with Govt. Department/Autonomous Organ./ PSEs/PSUs /Subordinate office etc. The calendar should be delivered properly packed in a paper box covered with polythene packing and the quotation should include all items of packing. GST

Rate should be clearly and separately mentioned in the quotation. No transport charges will be admissible for delivery of above material in the Foundation.

4. The 'Technical Bid' should contain quality of paper to be used, printing quality and experience of designing Calendars and Annual Report. The bid may be sealed in separate envelope superscripted as "Technical Bid for Printing of Calendar of NFCH for 2019" and "Technical Bid for Printing of Annual Report" as the case may be. Parties interested in submitting bids for one item only may do so without quoting for the other item. The 'Price Bid' should be submitted for printing and supply of 1600 copies of calendar in a sealed envelop superscripted as "Price Bid for Printing of Calendar of NFCH for 2019". The 'Price Bid' for printing & supply of 400 copies of Annual Report should be submitted in a sealed envelope superscripted "Price Bid for printing & supply of Annual Report". The sealed envelopes, one for each quotation should be addressed and delivered to **Secretary, National Foundation for Communal Harmony, 9th Floor, C Wing, Lok Nayak Bhawan, Khan Market, New Delhi-110003.**

5. The quotations should reach the office of Secretary, NFCH on the address as given above on or before 11th December 2018 by 2:00 PM and the quotations will be opened at 3:00 PM on the same day for further necessary processing. The envelopes containing Price Bid will be opened in respect of those Bidders, who qualify in the Technical Bid. Secretary, NFCH shall have the power to accept or reject any bid or rescind the contract without assigning any reason thereof and his decision shall be final and finding.
