### (A) Terms & Conditions:

- 1. The C.A./C.A. firm must have experience of internal audit of Government/ Statutory body/Autonomous bodies, etc.

- 3. The audit process set by the Foundation will be communicated at least 15 days before starting of the audit, to C.A./C.A. firm.
- 4. The NFCH or its authorized person shall supervise the audit and audit party shall explain the audit procedures and findings if asked for during the course of audit or even before and after.
