INTRODUCTION

The National Foundation for Communal Harmony (NFCH) is an autonomous organisation with the Ministry of Home Affairs. It was registered on the 19th February 1992 under the Societies Registration Act, 1860. Its office is located on the 9th Floor, 'C' Wing, Lok Nayak Bhawan, Khan Market, New Delhi -110003.

Objectives

- The objectives of the Foundation are to:
 - undertake programmes or projects for providing assistance to the children of families affected by communal, caste, ethnic or terrorist violence which fracture social harmony, as may be decided by the Governing Council from time to time in particular for their care and education;
 - (ii) undertake programmes or projects for assisting in the physical and psychological rehabilitation of the children, families or other victims of communal, caste, ethnic or terrorist violence / clashes which fracture social harmony for their assimilation into the mainstream of society as may be decided by the Governing Council from time to time;
- (iii) promote or undertake activities for the promotion of communal harmony and national integration including, but not limited to, scholarships, fellowships and studies;
- (iv) undertake and encourage activities which will promote belief in the principles of non-violence in resolving disputes between different religious and other groups in society;
- (v) institute Awards to individuals as well as institutions for their outstanding contributions to the cause of promoting communal harmony and national integration;
- (vi) cooperate with and secure the cooperation of the Central Government, State Governments, Union Territory Administrations, industrial & commercial organizations, non-governmental, voluntary & other organisations and bodies in promoting the objectives of the Foundation;
- (vii) provide information services, set up libraries, bring out journals, books or other forms of literature to promote the objectives of the Foundation;

(viii) do all such other lawful acts and things as may be necessary or conducive for furthering the objectives of the Foundation.

II - ORGANISATION AND MANAGEMENT

3. The Foundation has two main bodies to carry out the objectives set out for the Foundation, namely, the Governing Council and the Executive Council. While the Governing Council formulates overall policies, the Executive Council is responsible for the management and administration of the Foundation. The Governing Council consists of 25 members with the Union Home Minister as its Chairman (Annex-V). The Executive Council has eight members with the Union Home Secretary as its Chairman (Annex-VI). The Secretary of the Foundation is the Principal Executive Officer.

Funds

4. The Government of India provided a corpus fund of Rs.10 crore to the Foundation on its establishment in 1992. The corpus fund was enhanced to Rs.11 crore in 2004 following merger of Communal Harmony Fund of rupees one crore with the corpus fund of the Foundation. To augment its resources, the Foundation makes appeal to the general public, various State Governments / Union Territory Administrations, Central Government Departments, Public Sector Undertakings / Enterprises, educational institutions, etc. for voluntary donation to the Foundation for its noble cause. All donations to the Foundation are fully exempted from Income tax under Section 80G (iii)(e) of the Income Tax Act, 1961. The Government of India vide Department of Personnel & Training O.M.No.11013/9/95-Estt (A) dated 02.11.1995 relaxed the provisions of rule 12 of the Central Civil Services (Conduct) Rules, 1964 to allow Central Government servants to participate in the fund raising efforts of the Foundation on a voluntary basis (Annex-I). Similar relaxation has also been given by few State Governments allowing State Government servants to participate in the fund raising efforts of the Foundation on a voluntary basis. These include governments of Goa, Himachal Pradesh, Punjab, Kerala and Sikkim.

III-ACTIVITIES AND PROGRAMMES

5. The major activity of the Foundation is to implement programmes and projects for assisting in the effective rehabilitation of child victims of communal, caste, ethnic, terrorist and any other form of violence / clashes

which fracture social harmony. The emphasis remains on providing assistance to such children for their education and promoting communal harmony and national integration through various kinds of promotional activities.

- 6. The existing programmes of the Foundation may be categorized as:
- Project Assist
- Project Recognition
- Communal Harmony Campaign Week
- Project Research
- Library & Publications
- > Extension Activities and
- Other activities

Brief about these programmes is explained hereunder:

Project 'Assist'

- 7. Under the Project 'Assist', financial assistance is provided to children who become orphan or destitute due to death or permanent incapacitation of either both the parents or the main bread earner in the family in communal and other forms of societal violence. The children whose family's income is only up to Rupees One Lakh per annum are eligible for the financial assistance under the project. Each identified child is provided financial assistance @ Rs.1,000 per month for carrying out his/her studies up to class XII; Rs.1,250 per month for the students doing graduation / postgraduation and Rs.1,500 per month to the students of professional courses (like medical, engineering and management) without any restriction on the number of children in a family. The assistance is given till the child attains the age of 25 years.
- 8. A total number of 11,382 children have been benefited under the Project 'Assist' from the year 1992-93 to 2013-14 (Annex-II). Year-wise number of assisted children is at Figure-1. Expenditure of Rs 54.30 crores has been incurred since the inception of the scheme on assistance to child victims as on 31.03.2014. A sum of Rs 5.29 crores was incurred on Project 'Assist' during the year 2013-14, covering 3,918 children (Annex-II). Up-dated year-wise expenditure on this Project is at Figure-2. From different States, 184 new eligible children were identified and provided assistance in

- 2013-14 as against 165 new eligible children who were identified and provided assistance during 2012-13. Year-wise accretion of children assisted by the Foundation is at Figure-3. State-wise number of assisted children is at Figure-4.
- 9. Proposals of eligible children, either fresh or renewal, are received through the concerned district administrations. These proposals are examined and processed by the Foundation. Thereafter the assistance to children is released through the concerned District Collectors / Magistrates / Deputy Commissioners etc. for further disbursement to each child by the concerned district administration. Immediately after release of assistance by the Foundation, the affected families are informed to get timely payment through the office of the respective District Collector/Magistrate or Deputy Commissioner.
- 10. The Foundation also seeks cooperation from concerned State Governments, District Administrations, Non-governmental and other organizations for identifying eligible child victims for consideration of their proposals for grant of financial assistance. In Assam, a unit functioning under the Assam Police, namely Aashwas is helping the Foundation in identifying child victims of violence. Similarly, in J&K, the 'Council for Rehabilitation of Widows, Orphans, Handicapped & Old Persons' is also facilitating the Project Assist in the State.

Project 'Recognition'

11. The Foundation has instituted two National Communal Harmony Awards one in the 'Individual' category and the other in the 'Organization' category to be decided/ selected annually by a Jury under the Chairmanship of Hon'ble Vice President of India for outstanding contribution of organization(s) and individual(s) for promoting communal harmony and / or national integration. The Awards carry a certificate & cash amount of Rupees Five Lakh for an individual, and a certificate & cash amount of Rupees Ten Lakh for an organization. These Awards are conferred to the Award Winners in an investiture ceremony held once in two years at New Delhi. During the year 2013-14, two major events took place in connection with Project 'Recognition'. (i) Conferring of the National Communal Harmony Awards 2011 & 2012 in the Award Presentation Ceremony organized by NFCH on 20th September 2013 at Vigyan Bhawan, New Delhi. (ii)

Selection and announcement of the National Communal Harmony Award winners for the year 2013 by the Jury headed by the Hon'ble Vice President of India in a meeting held on 22nd January 2014 at VP House, 6 Maulana Azad Road, New Delhi.

Award Presentation Ceremony held in 2013

12. The Foundation organized a well-attended, glittering Award Presentation Ceremony at Vigyan Bhawan on Friday, 20th September 2013. Hon'ble President of India Shri Pranab Mukherjee conferred the National Communal Harmony Awards on Shri Khamliana, Mizoram and Shri Md. Abdul Bari, Odisha for the year 2011 and the Foundation for Amity & National Solidarity, Delhi for 2012. The Vice President Shri Mohammad Hamid Ansari, the Prime Minister Dr. Manmohan Singh, the Union Home Minister Shri Sushilkumar Shinde, Shri L K Advani and several distinguished and eminent leaders graced the occasion. In addition to presentation of the Awards, the event was addressed by the Hon'ble President of India, the Vice-President, the Prime Minister and the Home Minister.

13. Shri Khamliana (Mizoram) who received this Award for the year 2011 is the Founder President of the Mizoram Youth Club, Aizawl. The Club has done exemplary work in diverse fields i.e. extending support for rehabilitation of drug addicts, victims of AIDS and other similarly affected people. Shri Khamliana is actively engaged at the grass-root level with the youth and has organized several musical concerts, essay competitions and cultural exchange programmes to promote national integration and unity. He has also published six books in regional languages on different themes inter-alia highlighting the imperative need to promote national integration and communal harmony.



14. Shri Md. Abdul Bari (Odisha) is the President of the Bhadrak Muslim Jamat. He is a known social activist who has been working towards maintaining communal harmony in the area. Shri Bari has selflessly helped the police and local administration to maintain peace, unity and harmony in the district. The personal example set by Shri Abdul Bari and his meritorious and creditable services to the society have inspired the present generation to promote an atmosphere of peace and harmony amongst the different religious communities residing in the district.



15. The Foundation for Amity & National Solidarity (FANS) is a Delhi based social organization which works to spread and promote amity and communal harmony in the country. Established in 1984, the Foundation under the leadership of Shri Virendar Mohan Trehan is actively engaged in promoting communal harmony and national integration. The Foundation in more than 28 years of service to the nation has organized hundreds of events comprising of workshops, inter-religious meets, symposia, youth camps, Sadbhavana Sabhas and Peace Marches all over the country. The Foundation also conducted four Regional Children camps and 14 All India Inter University National Integration Youth Camps in different parts of the country.



Selection of the National Communal Harmony Award winners of 2013

- 16. Nominations for these Awards are invited every year as per the set procedure. An advertisement inviting nominations for the National Communal Harmony Awards for 2013 was published on Sunday the 5th May 2013 in 41 newspapers in different languages throughout the country. In addition, nominations were also called for from about 3700 sponsoring authorities from all the States / Union Territories forwarding them a copy of the Award Brochure 2013 with the request to identify and recommend the nominations of eligible Individuals & Organizations. The Award scheme of the Foundation was also given wide publicity on Doordarshan and All India Radio.
- In all, the Foundation received 49 nominations in both the categories for the year 2013. Out of these 49 nominations, 23 nominations i.e. 04 in the 'Organization' category and 19 in the 'Individual' category were found eligible and placed before the Jury for consideration. The Jury under the Chairmanship of Honb'le Vice President of India in a Meeting held on 22nd January 2014 at 6 Maulana Azad Road, New Delhi selected one organization viz. the Centre for Study of Society and Secularism, Maharashtra for this prestigious Award for the year 2013 in the 'Organization' category and two individuals viz. Dr. N. Radhakrishnan, Kerala and Dr. Mohinder Singh, Delhi in the 'Individual' category. These Awards were announced on 26th January 2014 as per the practice.
- 18. Established in 1996, the Centre for Study of Society and Secularism (CSSS) is a Mumbai based organization working to promote peace, secularism and communal harmony in the country. It has also been working on human rights issues and issues of the



marginalized and deprived sections of the society. The Centre has published a number of books and literary material highlighting different facets of violence and communalism, peace, secularism and communal harmony which have a wider readership. The Centre

has also been regularly publishing a quarterly journal 'Indian Journal of Secularism' which is popular amongst academics and the masses.

19. **Dr. N Radhakrishnan** is a well known academic,

a Gandhian scholar and a peace worker. He initiated the Shanti Sena programme at the Gandhigram University and extended this work to other parts of the country. He has been actively working to restore peace



in communally tense areas of Tamilnadu and Kerala. Having served as Director of Gandhi Smriti & Darshan Samiti, New Delhi for more than a decade. He was instrumental in initiating and implementing many innovative activities in educational institutions by using Gandhian values and principles. His campaign 'Himsamukth Bharat Andolan' motivates people to become foot soldiers in campaigning for peace and sustainable development.

20. **Dr. Mohinder Singh** is a scholar and member of the National Commission for Minority Educational Institutions. Earlier, he was also Member of the National Commission for Religious and Linguistic Minorities from 2005 to



2007. In 1984, he along with other social activists, organized relief camps at Delhi and restored friendship between the Hindu and Sikh communities in the wake of anti-Sikh riots. In 1985, he set-up a Communal Harmony Forum along with Dr. Nirmala Deshpande, which worked for nearly four years and organized interfaith meetings and visit to holy places by its members.

21. The Awards to the above mentioned Award winning organization and individuals will be conferred in an investiture ceremony to be held sometime in 2015 at New Delhi.

Communal Harmony Campaign Week

22. The Communal Harmony Campaign Week was observed as an annual feature from the 19th to 25th November to coincide with the Qaumi Ekta week. On

the occasion, an appeal was made to the general public, State Governments / Union Territory Administrations, Ministries / Departments, Public Sector Enterprises, Embassies / Missions abroad, para-military forces, educational institutions, etc. to effectively promote the values of communal harmony and national integration amongst the people specifically the youth. An appeal was also made to organize a determined and sustained drive to bring about mass-awakening against violence which disturbs social harmony by making appropriate projection through the media as also to donate funds on voluntary basis to augment the financial resources of the Foundation to enable it to carry on its activities.

- 23. The Foundation got publicity material printed and distributed to State Governments / UT Administrations, Ministries / Departments, Central Public Sector Enterprises, para-military organisations, educational institutions and our diplomatic missions abroad. In all, publicity materials were sent to about 99,500 units all over the country during the year 2013 as against about 99,300 units during 2012. Details of dispatch of publicity material to various units during 1992-93 to 2013-14 are at Figure 5.
- 24. For observance of the Communal Harmony Campaign Week and pinning of Flag on the persons of VVIPs, two children financially assisted by the Foundation from Jammu & Kashmir, Assam and one child from Maharashtra along with their guardian and one escort (state government representative) were invited to participate in the Flag Day programme. The arrangements for their board and lodging were made at the guest houses of the concerned State Governments. The invited children along with their guardians and escorts were taken to Raj Ghat, Jama Masjid, Lal Qila, Qutub Minar, Lotus Temple, Rail Museum, Rashtrapati Bhawan, India Gate, etc.



The Communal Harmony Campaign and fund raising week was observed throughout the country with enthusiasm. Cultural programmes, debates, seminars, symposia, painting competitions and marathon involving children of various communities with the aim of spreading communal harmony and national integration were organized in which large number of students, teachers, parents and employees participated. Rallies with banners were also organized as part of celebrations. Posters and paintings giving message of unity in diversity, communal harmony and national integration attempted by school children were received from several schools all over the country. Appreciation certificates were sent to those schools for distribution to students placed at 1st, 2nd and 3rd position as well as to those who participated in these activities by the school authorities to encourage students to continue their efforts in spreading the message of peace, non-violence, communal harmony and national integration.



26. The highlight of the observance of the Flag Day on 25th November 2013 was symbolic pinning of flags by a group of assisted children from Jammu & Kashmir, Assam and Maharashtra on the persons of Hon'ble President, Hon'ble Vice President, Hon'ble Prime



Minister, Hon'ble Union Home Minister and Hon'ble Home Secretary. After the visit by invited children, the VVIPs appreciated the efforts of NFCH and expressed their commitment for spreading the message of national integration and communal harmony.

Project 'Research'

- 27. The Foundation sponsors proposals for conducting study / research received from universities, research organisations, schools of social work, autonomous organisations, renowned institutions working in the field, individuals, etc. for empirical, participatory and action-oriented research and other studies having strong relevance to promotion of communal harmony and strengthening of national integration. Under this scheme, the Foundation can also entrust or collaborate with reputed research institutions to carryout suitable research studies for achieving the mandate of the Foundation.
- 28. During previous years, the Foundation entrusted two research projects for conducting evaluation studies of its flagship scheme Project 'Assist', one to Manipur University and the other to University of Kashmir. Both these studies are under progress and in the final stage of report writing by these universities.

Library and Publications

- 29. The Foundation has established a library having approximately 3400 books, journals and reports principally on the subject of communal harmony and national integration. The literature available in the library is being used by the officials of the Foundation and consulted by professionals/scholars/students from time to time. Setting up of the library has facilitated carrying out research work on various aspects of communal harmony and national integration. Details of books and other relevant literature available in the library of the Foundation can be seen on the website https://nfchlibrary.nic.in.
- 30. Two books titled 'Hum Ek Hain' (Second Edition) and 'Shanti Vriksha' were published by NFCH during 2013-14. The Foundation has so far published 19 books and monographs to promote communal harmony and national integration. The Foundation has published Flyers on 'Guidelines to promote Communal Harmony and National Integration' which contain several workable and useful suggestions that organizations and individuals can take up in areas

where they are residing or working to promote societal harmony, love, amity and brotherhood amongst the people. The Flyers have been circulated widely and have been received warmly and with enthusiasm by all those who have seen them. Book-marks to promote the theme of communal harmony have been published to instil this feeling amongst the youth and common people. The Foundation has also published and circulated its Calendar for the year 2014 to enhance its outreach and visibility amongst stakeholders as well as common citizens of the country. The list of publications of the Foundation is at Annex-III.

NFCH Newsletter- 'Sadbhavana Sandesh'

The Foundation launched its periodical tri-lingual Newsletter 'Sadbhavna Sandesh' in the year 2013 with a view to promote communal harmony and strengthen national integration. The newsletter includes suitable write-ups, stories relating to current developments in the area of peace, communal harmony and national integration and poems etc. in English, Hindi and Urdu. Since, the launch of its inaugural issue in August 2013, Sadhbavana Sandesh is receiving appreciation from different quarters. During the year 2013-14, three issues of this Newsletter have been successfully published and circulated amongst different stakeholders including officers of state governments, educational institutions. NGOs. Think Tanks, civil society groups, social organizations and individuals from different social and religious backgrounds to spread the message of peace, amity and social harmony. All the issues of this Newsletter are also being uploaded from time to time on the website of the Foundation for wider readership.

Extension Activities

32. The Foundation under its Extension Activities viz. Reach, Interfaith-Interaction, Partnership and Cause-Partnership takes up, various activities, either independently or through State Governments / Administrations, non-governmental organizations, educational and other institutions etc. with a view to promote communal harmony and national integration. Financial assistance is provided by the Foundation to State Govts. / NGOs, educational and other institutions for organizing activities for promoting communal harmony and national integration.


32.1 Under Project 'Reach', there is a provision of providing financial assistance up to Rupees Five Lakh per annum per State/UT for promotion of communal harmony and national integration in the concerned States / UTs. The programme envisages organisation of debates, seminars, workshops, paintings, poster / slogan and essay writing competitions, music, cultural programmes, mushairas, etc. either directly by the State Governments / UT administrations or through non-governmental organisations.

32.2 Scheme 'Interfaith-Interaction' envisages provision of financial assistance up to Rs.50,000 per festival per annum for two festivals in a State/UT for organizing inter-community interaction on festivals like Id, Deepawali, Christmas, Baisakhi, Lohri, Onam, Pongal and festivals / fairs such as Phool Walon Ki Sair in Delhi, Deva Sharif at Barabanki and Nauchandi at Meerut in Uttar Pradesh through non-governmental organizations, colleges, universities, etc.

32.3 Scheme 'Partnership' has provision of partnering with (a) UN organizations, (b) different Government organizations (like NYKS, NSS etc.) and (c) renowned All India level VOs/NGOs for furthering the objectives of the Foundation. Maximum annual provision for this scheme has been kept as Rs.5 lakh out of the total budget for Extension Activities per year.

32.4. Scheme 'Cause-Partnership' provides that the Foundation may associate itself with other Government Departments, UN organizations, educational institutions or VOs/NGOs to promote communal harmony and national integration without provision of any financial assistance.

33. Brief reports on the extension activities undertaken during the year 2013-14 are as follows:





33.1 NFCH in collaboration with Indian Council for Cultural Relations organized a Kavi Sammelan and Mushaira 'Sadhbhavana Ke Swar' on 26th June. 2013 at Azad Bhawan Auditorium in I.P. Estate, New Delhi. The programme was graced by Shri K. Skandan, Additional Secretary, Ministry of Home Affairs who appreciated activities being undertaken by the Foundation for promoting communal harmony and strengthening national integration. He advised the Foundation to carry on such activities in different parts of the country so that this message is received and adopted by large segments of population. Shri Ashok Sajjanhar, Secretary of the Foundation briefed the audience about its objectives and the financial assistance being provided to the children affected by communal, caste, terrorist and societal violence for their care, education and rehabilitation. He sought cooperation and partnership of people from all walks of life in further carrying out the vision and mission of the Foundation. The programme was attended by various distinguished and eminent personalities like Ambassadors, Heads of Institutes, NGOs, Think Tanks, Civil Society groups and others.

Sadhbhavana Ke Swar is an untiring attempt to disseminate the message of communal harmony and national integration. 10 eminent Hindi and Urdu Poets participated in the programme. They regaled the audience with their creative compositions. The recitation to the packed hall was generously and continuously applauded. The event was inspiring and motivating. This attempt by the Foundation will go a long way in promoting peace and communal harmony amongst the diverse religious, ethnic and other segments of our society.

Remembrance Meet to pay homage to the memory of Dr. Asghar Ali Engineer organized by NFCH on 11th July 2013 at New Delhi

33.2 The National Foundation for Communal Harmony (NFCH) in collaboration with the National Commission for Minorities (NCM) and Gandhi Smriti and Darshan Samiti organized a Remembrance Meet to pay homage to the memory of Dr. Asghar Ali Engineer who passed away on 14th May 2013.

The meeting was organized in the Conference Hall of the National Commission for Minorities. A large number of distinguished and eminent scholars, activists, academics, authors and collaborators of Dr. Asghar Ali Engineer participated in the Meeting. Several of them also spoke at the Meeting. These included Sh. Wajahat Habibullah, Chairperson, NCM; Justice Rajinder Sachar; Dr. V. Mohini Giri, Founder Chairperson, Guild for Services; Prof. Akhtarul Wasey, HoD (Islamic Studies); Dr. A.K. Merchant; Sadhvi Guru Chhaya; Rev. Dr. Dominic Emmanuel SVD, Catholic Arch Diocese; Shri V.M. Trehan, Founder, Foundation for Amity and National Solidarity; Shri K.G. Suresh, Director and Chief Editor, Global Foundation for Civilizational Harmony (India) etc.

Two important suggestions were made at the meeting: (i) To establish a Chair named after Dr. Asghar Ali Engineer to take forward the ideals and thoughts that he espoused for promotion of communal harmony, national integration, peace and non-violence in the country and (ii) To organize an Annual Memorial Lecture in the memory of Dr. Asghar Ali Engineer in Delhi or Mumbai focusing on his thoughts and writings.

Seminar & painting and debate competition for school children organized by Tarusakha at Maner, Patna, Bihar

33.3 Tarusakha, a Patna (Bihar) based NGO organized a one day Seminar on the 'Role of Youth in Promoting Integration and Harmony' on 25 August 2013 and a painting and debate competition for school children on 30 August 2013 in Maner, Patna (Bihar). Financial assistance of Rs.40,000 was provided by NFCH.

One day Seminar organized by All India Women's Conference on 24th September 2013 at Thiruvanathapuram, Kerala

33.9 AAROHAN, a Delhi based Non-Governmental Organization, organized a one day programme in collaboration with the National Foundation for Communal Harmony to promote communal harmony and national integration on 4th January 2014. The programme was held near Lakshmi Narayan Mandir, Malviya Nagar, New Delhi. Amb. Ashok Sajjanhar, Secretary NFCH and Shri Sourabh Dubey, Assistant Secretary participated in the programme. The event was graced by Shri Narendra Chitra, Laxmi Narayan Mandir; delegates from Delhi government; Maulana Sabre Alam Qadri and several other distinguished quests and participants.

A Seminar on 'Inter-religious Cooperation for Nation Building' was organized by NFCH on 20th January 2014 at New Delhi 33.10 The National Foundation for Communal Harmony (NFCH) organized a Seminar on 'Interreligious Cooperation for Nation Building' on 20th January 2014 in the Conference Room of the National Commission for Minorities, New Delhi.



The Seminar was chaired by Amb. Ashok Sajjanhar. In his introductory remarks, he spoke of the current communal situation in the country and emphasized the need for taking concrete steps to promote communal harmony and national integration in the backdrop of the recent Muzaffarnagar incidents. Keynote address was delivered by Swami Sachidananda Bharathi, a former Indian Air Force Officer & Founder, Dharma Bharathi Mission and a well known and respected spiritual leader. In his address, Swami Sachidananda Bharathi stated that moral and spiritual values in the society are nurtured and nourished best by religion. Religions need to join hands. This is possible, if religions themselves are morally and spiritually awakened and revitalized. There has to be a comprehensive action plan for spiritual regeneration of India by setting-up of a network of 'National Eco-Spiritual Parks' to promote ecological health and spiritual unity of the country. He stated that destiny of India and the future of humanity will depend on the courage with which peace loving people of this country belonging to different religious traditions respond creatively to the call of Yuga Dharma. Swami Sachidananda specifically shared the miseries and sufferings of the violence affected victims of recent Muzaffarnagar disturbances in Uttar Pradesh and enumerated the reconciliatory measures being organized for rehabilitation of the people. Prof. Haribhau Kedar illustrated the idea of a 'National Pilot Project' to promote communal harmony, sustainable peace and development in four districts of Muzaffarnagar, Meerut, Shamli and Saharanpur by

training and developing a dedicated cadre of about 400 enlightened youth leaders for this mission. 'Tyagarchana', formulated by Swami Sachidananda Bharathi, will be one of the important elements of this mission for spiritual unity and regeneration of the country.

The seminar was also addressed by eminent personalities including Air Chief Marshal N.C. Suri; Prof. Haribhau Kedar, Director General, Dharma Bharathi National Institute of Peace & Value Education (DBNI); Dr. Archana Pande, Principal, City Montessori School, Lucknow; Prof. Md. The programme was conducted by Amb. Ashok Sajjanhar, Secretary, NFCH who also delivered opening and concluding remarks.

Symposium on 'Understanding Qawwali' organized by Sufi Kathak Foundation & NFCH at India International Centre, New Delhi on 8-9 March 2014

The Sufi Kathak Foundation, Delhi with partfinancial support provided by NFCH organized a two days' symposium titled 'Understanding Qawwali' at India International Centre, New Delhi from 8th to 9th March 2014. The programme was dedicated to Qawwali, exploring the plurality of the unified art-form. It featured researchers, scholars, film makers, photographers and connoisseurs of music and traditional performers and practitioners associated with this style. The symposium was uniquely conducted to enlighten the people about Qawwali as a traditional art form of Indian sub-continent and present it as a cultural symbol to represent the essence of 'unity in diversity' of India. The symposium included scholarly discussions on unifying as well as plural aspects of Qawwali focusing on musical structure of various forms.

Ms. Manjari Chaturvedi, President Sufi Kathak Foundation welcomed the audience with her opening remarks. Ms. Gillian Wright, one of the moderators delivered the introductory note on the theme of the symposium. Amb. Ashok Sajjanhar, Secretary NFCH and the presiding Chair of the symposium, discussed the popularity of Qawwali across South Asia and stressed the syncretic assimilation of various music forms with the Qawwali.

33.12 A one day seminar titled 'Towards an Inclusive Society' was jointly organized by NFCH, Office of Public Affairs of the Bahá'ís of India, and the Voluntary Action Network-India (VANI) at the India Habitat Centre on 12 March 2014.

Ambassador Ashok Sajjanhar, Secretary, NFCH, welcomed participants, stating that the foremost achievement of India in the eyes of the international



community is its rapid economic growth. "But has this helped India become an inclusive society?" asked Ambassador Ashok Sajjanhar. "Are there adequate possibilities for all people – individuals, groups and institutions – to benefit from the growth that has taken place?" These questions provided a platform for lively discussions throughout the seminar.

The Keynote address by Dr. Karan Singh, MP, Rajya Sabha, outlined 7 dimensions of inclusion that need to be addressed to deal with the underlying causes of exclusion. The first panel discussion included speakers who addressed issues of identity and inclusion related to gender, youth and children." Ms. Aditi Kaul, representing the YP Foundation challenged the participants to re-conceptualize inclusion away from a mere numeric measure of participation towards a deeper understanding of how we include young people in policies and programs. Ms. Razia Ismail, Convener of the India Alliance for Child Rights (IACR) challenged participants to climb out of the "we/they" categorization of individuals in society.

Air Chief Marshal (Retd.) N.C. Suri and Professor B.S. Bhasin led the panel discussion on Communal Harmony, National Integration and Peaceful Coexistence by focusing on the importance of religion and acceptance of religious diversity. Mr. Suri focused on the fundamental truths that unite all religions while Prof. Bhasin called on going beyond tolerance of others towards genuine acceptance of religious diversity. The moderator of the panel, Mr Amitabh Behar, Director of National Foundation for India (NFI), highlighted the importance of addressing issues of justice and equity in discourses of inclusion.

Mr. Jayant Kumar, Chairperson of VANI and Head of Programmes in CASA, opened the panel discussion by noting that media has the power to change peoples' "hearts and minds" — especially on issues related to identity, harmony and national integration. Mr. K.G. Suresh of the Global Foundation of Civilizational Harmony stated that media has the responsibility to report on harmonious actions of citizens in addition to reporting on cases of violence and disharmony without sensationalizing violence. Mr. Sandeep Dikshit from The Hindu spoke about a few "rays of hope" in media which include the entrance of young people with social consciousness in the field of media who are not beholden to financial or political interests. He noted that "there has to be a difference between news and views."

Mrs. Farida Vahedi, Director of the Bahá'í Office of Public Affairs wrapped up the day's proceedings prior to introducing the Valedictory speaker, Dr Syeda Hameed, Member of the Planning Commission. Dr Hameed focused on the 12th Five Year Plan (2012 – 2017) as a focal point around which Civil Society and Informed Citizens can rally to bring duty bearers to account for implementing the vision set forth for a more inclusive growth.

KNOW MY INDIA Programme- a Maiden attempt by NFCH was held at Hyderabad from 22-28 March 2014

33.13 The National Foundation for Communal Harmony in collaboration with Siasat Daily, an Urdu Newspaper of Andhra region, organized the **Know My India Programme** at Hyderabad from 22-28 March 2014. The programme was an integrated effort of the Foundation to acquaint the children, who receive financial support from the Foundation for pursuing their education to the varied and diverse culture of the country.

The concept of the **Know My India Programme** is to bring together these children from different States and regions at one place to promote oneness, fraternity and national integration. Shri Zahid Ali Khan, Editor of Siasat Daily, voluntarily offered to host the programme in Hyderabad. The Foundation invited 10 children with their escorts from Assam and Manipur States to participate in this programme. Ms. Hafiza Muzaffar, Executive Director, State Rehabilitation Council, Deputy Commissioner of Kupwara and Social Welfare Officer of the district warmly thanked and commended NFCH for its generous support to the children of the State.

While expressing their gratitude and appreciation for the support extended by the Foundation, a few of them also requested that the amount of assistance be increased. It was explained to them that the quantum of support has been increased from Rs.9,000 per annum to Rs.12,000 last year and from Rs.12,000 per annum to Rs.15,000. In addition, the age limit has been increased from 18 years to 25 years in 2012 thereby enabling the beneficiaries to pursue higher studies in

Ashok Sajjanhar shared his views, how the children and youth could achieve their goals in life and productively contribute towards the growth and development of our country. He exhorted them that the past incidents of violence should not come in the way of their educational attainment and development, and they should work hard to fulfill their dreams in life.

Meeting with the children and guardians was immensely inspiring, gratifying and satisfying. One of the boys who is doing Engineering has been selected as a Google Ambassador of the State and will be taken to Goa at expense of the Google company for further training and skill development. Two boys who are twins and are studying in the final semester of Medicine have consistently featured in the top few positions in their class for the last many years. The decision last year to enhance amount of assistance from Rs.9,000 per annum to Rs.12,000 per annum and from Rs.12,000 per annum for higher studies to Rs.15,000 per annum was warmly welcomed. Enhancement of age limit from 18 to 25 years was also welcomed and gratefully acknowledged.

Some women raised the issue of being provided jobs or training so that they could learn some skills and earn a decent living for themselves. Ambassador Sajjanhar was impressed and inspired with the confidence, determination and dedication with which the children and their guardians are dealing with the enormous adversity they have had to confront.

Amb. Ashok Sajjanhar honoured with 'Ambassadorfor Peace' Award by UPF

34.3 Amb. Ashok Sajjanhar, Secretary, National Foundation for Communal Harmony was awarded the Title of 'Ambassador for Peace' by the Universal Peace Federation, New York, an Organisation in Consultative Status with the United Nations on 4th January, 2014 at the United Nations Office, New Delhi for his contribution and initiatives in promoting communal harmony, peaceful co-existence and mutual respect for all religions. This prestigious Title was conferred to Amb. Sajjanhar by Dr. Thomas Walsh, International President of UPF and Dr. B.P.Singh, former Governor of Sikkim.



On this occasion Amb. Ashok Sajjanhar delivered a Talk on the Relevance and Future of Interfaith Movement and the important role that India is playing in promoting societal harmony, unity, amity and brotherhood amongst the diverse segments of our society in the country and the world. He said that for the last several millennia, all major religions and faiths of the world have flourished and blossomed in India. India is a vibrant and outstanding example showing how different faiths and beliefs can co-exist in peace, mutual respect and harmony.

Programme organized on Cooperation amongst Religions for Nation Building at Sardhana, Meerut

34.4 The Dharma Bharathi Rashtriya Sanstha, Regional Centres Nagpur & Meerut, organized a one day program on *'Rashtra Nirman Hetu Samast Dharmon ka Sahyog'* on 18th February 2014 at St. Joseph's Girls Degree College, Sardhana, Meerut. The main objective of the program was promoting peace, spirituality and communal harmony for nation building. The program, in addition to a prayer dance by college

students, included insightful speeches by eminent resource persons.

Amb. Ashok Sajjanhar delivered the Presidential address at the program. Swami Sachidanada Bharati highlighted the need for national harmony through Tyagarchana- Shanti Yojna program. Bishop Francis Kallista blessed the assembled congregation. Shri Arif Mohammad Khan shared his thoughts on joy of cooperation between all religions for nation building. Dr. Maj. Himanshu encouraged the students to make concerted efforts for promoting peace and communal harmony for nation building.

Other main speakers of the program were Fr. Sahyadas, Sister Christina, Rev. Fr. John Chimman and Fr. Peter Antony. Vote of Thanks was delivered by Sr. Christina. The program went a long way in inculcating a sense of unity, peace and cooperation among the students of the college and teaching faculty.

AIACHE, New Delhi organised program on Nation Building

34.5 The All India Association for Christian Higher Education (AIACHE), Janakpuri, New Delhi organized a three day programme of Interfaith Dialogue: Policy and Prgramme Development on the theme, 'The Role of Religion in Nation Building' from 20th to 22nd February 2014. It was an inspiring interactive experience of educational administrators of Christian Colleges in India for Policy and Prgramme Development on Interfaith Dialogue.

Shri Abdur Rahman, MP; Amb. Ashok Sajjanhar, Secretary, NFCH; Dr. Sudhir Joseph, Director, St. Stephen's Hospital; Shri Robert Winter, United Board for Christian Higher Education in Asia, Myanmar were the Guests of Honour. In addition, a number of renowned academics and resource persons participated as moderators and guest speakers for different sessions. The programme attracted a cross section of people representing different organizations and agencies.

During the inaugural session on 20th February 2014, Amb. Ashok Sajjanhar participated in this event as Guest of Honour and also spoke on the occasion highlighting the commonalities between different religions, how these commonalities have been instrumental in promoting communal harmony for nation building.

In addition to the Inaugural and Valedictory sessions, the programme included five specific sessions on 'Role of Religion in Nation Building' in Hinduism, Islam, Christianity, Sikhism, Buddhism, Jainism, Bahai Faith as well as on Communal Harmony in Multi-Religious Context; Building Interfaith Relationship, Religion and Social Change; and Dialogue on Policy and Programme Development on Interfaith Dialogue.

Secretary, NFCH delivered Talk at UGC ASC, Maulana Azad National Urdu University, Hyderabad

34.6 Amb. Ashok Sajjanhar delivered Talks on Human Rights & Communal Harmony during Refresher Course at Maulana Azad National Urdu University, Hyderabad.

The Academic Staff College, Maulana Azad National Urdu University, Hyderabad organized a three week Refresher Course from 6th to 26th February 2014 in Human Rights for Assistant Professors who came from different parts of the country. Amb. Ashok Sajjanhar, Secretary, NFCH participated in this programme as a key resource person presenting insightful views to a huge gathering of participants and the audience through Talks delivered by him on 25th and 26th February 2014 on international perspective of human rights, violence and communal harmony.

Essay Competitions

35. The Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie along with the three partner institutions of LBSNAA, namely the RCVP Noronha Academy of Administration, Bhopal; Dr. MCR Human Resource Development Institute of AP, Hyderabad and the National Academy of Direct Taxes, Nagpur organizes essay competitions every year on topics covering themes of communal harmony and national integration in collaboration with the Foundation.

Sadbhavana Clubs

36. The Foundation has helped in establishing Sadbhavana Clubs in a number of Kendriya Vidyalayas, Jawahar Navodaya Vidyalayas and State educational institutions. The basic objectives of the Sadbhavana Clubs are to sensitize students about the problems of communalism, terrorism, etc. and to

inculcate values of harmony, fraternity, brotherhood, tolerance, co-operation and non-violence in children, which help in promoting peace, unity and social harmony.

'Volunteers for Peace and Harmony' Programme

- 37. The Foundation has launched the programme Volunteers for Peace and Harmony (V for Peace-n-Harmony) in 2011. It is conceptualized to set up a national level network of Volunteers, which may play an important role in creating peace and harmony in the society. This programme would provide a platform to volunteers and increase the outreach of the Foundation.
- 37.1 In the first phase, volunteers associated with Civil Defence, NSS, NCC, NYKS, NYC, and students of various educational institutions were enrolled in the programme. Later those who are working with Mohalla Committees, RWAs, Sadbhavana Clubs, District Peace Committees, NGOs, etc. were also enrolled. Now the membership is open for all interested persons.

Web-site

- The web-site of the Foundation 38. (www.nfch.nic.in) was launched in 2002-2003. In the current financial year, the website has been given a new look. Now the website includes all the requisite information about the Foundation and its current activities such as details of assisted children including financial assistance released to them, books, journals, publications available in the library, application forms for grant of assistance under various projects, information regarding National Communal Harmony Awards, photo gallery, citizen's charter, RTI and information about different other activities of NFCH including seminars, rallies, etc. The number of visitors accessing NFCH website has increased considerably during the year under report.
- 38.1 The Foundation launched its Face-book Page in August 2013 for enhancing the outreach and visibility of the activities and programmes of the organization. It is proposed to cover all events and issues of interest and relevance to the working of the Foundation on the Face-book page for information of our partners, patrons, supporters and general public. Our Newsletter has also been uploaded on our Face-book Page for wider dissemination.

Staff

39. The Foundation has total staff strength of 17 personnel and three helpers on daily wage basis. The work relating to accounts, including issue of receipt for donations, project 'Assist' and library has since been computerized.

Donation

- 40. Year wise break up of donation received from 1992-93 to 2013-14 is at Fig. 6. Total donation of Rs 4.15 Crore was received during 2013-14 as compared to Rs.4.08 Crore received during 2012-13. The spirit of generous cooperation shown by PSUs / PSEs, corporate houses, individuals, organizations, etc. in donating for the noble cause is thankfully acknowledged. Despite our keen desire, it is difficult to mention all of our contributors in this Annual Report. Those who have contributed Rs.20,000 or more are listed at Annex-IV.
- 41. Some of the Central Public Sector Enterprises donated sizeable amounts as indicated against each in the above-referred Annex-IV for supporting various activities of the Foundation.
- 42. The Container Corporation of India Ltd. (Concor) sponsored project 'Assist' in Doda, Ramban and Poonch districts of J&K. The GAIL (India) Limited sponsored in Anantnag district of J & K and Kamrup (Metro & Rural), Dibrugarh, Golagarh, Tinsukia, Sonitpur and Udalguri districts of Assam. The Mishra Dhatu Nigam Limited, Indian Oil Corporation Limited, NMDC Limited and Bharti Enterprises Limited also provided financial support to the Foundation under their CSR policy for sponsoring children under project 'Assist' for their education and rehabilitation.

IV-ACCOUNTS AND AUDIT

- 43. The rules of the Foundation provide for the maintenance of proper accounts and other relevant records. The Foundation is also required to prepare an annual statement of accounts and get it audited by a chartered accountant or a firm of chartered accountants approved by the Governing Council.
- 44. M/s R. C. Chadda & Co., New Delhi has audited the accounts of the Foundation for the year 2013-14. The Auditor's Report is placed at Annex-VII.

V-SUMMING UP

- 45. To sum up, the Foundation continued to carry out its activities with unabated vigour. The year under report witnessed an increase in the cumulative number of children assisted from 11198 to 11382 under project 'Assist'. A total expenditure of Rs 5.29 crore was incurred on project 'Assist' during the year 2013-14.
- 46. For the National Communal Harmony Awards The Centre for Study of Society and Secularism, Mumbai, Dr Mohinder Singh, Delhi and Dr N Radhakrishnan, Kerala were selected for the Award in the organization and individual category respectively for the year 2013. Various extension activities were undertaken to spread the message of communal harmony. The Foundation has its own Library with about 3400 books, journals and reports. Web-site of the Foundation is being updated on regular basis and is fully operational for the public at large for obtaining requisite information about the Foundation.
- 47. The financial position of the Foundation is satisfactory and its funds are managed judiciously. The fixed deposits of the Foundation stood at Rs.46.8 Crores as on 31.03.2014.

Year-wise total number of assisted children from 1992 -93 to 2013 -14



Year-wise expenditure on project 'Assist' from 1992-93 to 2013-14



Year-wise accretion of children assisted from 1992-93 to 2013-14




Year-wise despatch of publicity material from 1992-93 to 2013-14




OFFICE MEMORANDUM

Subject: Observance of Flag Day by the National Foundation for Communal Harmony - Participation of Government Servants-CCS (Conduct) Rules 1964.

Under Rule 12 of the Central Civil Services (Conduct) Rules, 1964 no Government servant shall, except with the previous sanction of the Government or of the prescribed authority, ask for or accept contribution to or otherwise associate himself with the raising of any funds or other collections in cash or in kind in pursuance of any object whatsoever.

The National Foundation for Communal Harmony has been set up for promoting communal harmony and particularly for the physical and psychological rehabilitation of children rendered orphans and destitutes in communal violence. The Foundation has been engaging in efforts to collect contributions and observes every year a 'Fund Raising Week', and 'Flag Day', clarifications have been sought whether Central Government Servants could be associated with or involved in the above fund raising efforts of the Foundation.

The matter has been examined and keeping in view the objectives of the National Foundation for Communal Harmony, the Government of India have decided to relax the provisions of Rule 12 to allow Central Government servants to participate in the fund raising efforts of the Foundation on a voluntary basis.

SCHEDULE 15 & 16: SIGNIFICANT ACCOUNTING POLICES, CONTINGENT LIABILITIES AND NOTES TO ACCOUNTS

1.Accounting Convention

- **1.1** The financial Statements are prepared on the basis of historical cost convention and in accordance with the generally accepted accounting principles and standards.
- 1.2 The financial statements are prepared on accrual basis unless otherwise indicated.
- **1.3** Assistance to Children, Awards and Fellowships , are accounted as and when paid. No provision is made for future instalments of assistance to be provided to the children covered under the scheme of Project "Assist"

2. Grants/Subsidies

- 2.1 Government grants/subsidy are accounted for on realisation basis.
- **2.2.** Government grants of the nature of contribution towards capital cost of setting up projects are treated as capital reserve.
- **2.3** Grants in respect of specific fixed assets acquired are shown as a deduction from the cost of related assets.
- **2.4**. At present, the Foundation collects and Manitains details using dedicated software. One consolidated entry for all the donations is passed at the end of each month or Year in account books. In view of this, the bank accounts of the Foundation cannot be reconciled satisfactorily.
- **2.5** .Categorization of Garants / Donations among Government Agencies, Institutions, Welfare bodies and individuals (Schedule -7) is based on the coding system developed in software used for mainitaining donor details .Grants are included in donations and not identified separately .

3. Anonymous Donations

3.1 Anonymous donations of Rs. 48,94,433.24 represents direct deposit of cash/instruments in the bank account of the foundation. Names and other details of such donors is not available with the foundation.

4. Foreign Contribution

4.1 Receipt of Rs.7.85 crores on maturity of fixed deposits made out of local funds has been routed through designated FCRA bank accounts or bank transfers made by various individuals and institutions across the country and abroad. Names and other details of such well - wishers are not available with the Foundation. In the absence of this information, it is not feasible to state that none of these donations is from a foreign source as defined in sec.1(1) (h) of Foreign Contribution (Regulation) Act,2010.

5. Activities of the foundation

- **5.1**The foundation is an autonomous organization under the aegis of Ministry of Home Affairs and has been registered under the Societies Registration Act, 1860 in the year 1992.
- **5.2**The main activities of the Foundation include providing assistance to children affected by communal disharmony and other promotional activities for communal harmony in the country.
- 5.3 Expenditure on such activities is shown in Schedule-12 to the Income & Expenditure Account.

6. Inventory Valuation

6.1 Inventories, which consist of NFCH publications are stated at lower of cost or net realisable value. Cost of inventories is determined using first in first out (FIFO) formula.

7. Investments

- **7.1** There are no Ear marked funds. Corpus and surplus funda are kept invested in medium term government securities or Bank FDRs (shown as "Investment other") to generate fixed income (interest) to take care of the core activities of the foundation.
- **7.2** Investments are stated at cost. Interest accrued thereon is shown under "Loans, Advances and other assets".

8.. Tangible fixed assets

- **8.1** Fixed assets are stated at cost, net of accumulated depreciation and accumulated impairment losses, if any. The cost comprises purchase price and directly attributable cost of bringing the asset to its working condition for intended use. Further any trade discounts, rebates or input credits are deducted in arriving at the purchase price.
- **8.2** Subsequent expenditure related to an item of fixed asset is added to its book value only if it increases the future benefits from the existing asset beyond its previously assessed standard of performance. All other expenses on existing fixed asset, including day-to-day repair and maintenance expenditure and cost of replacing parts are charged to the statement of profit and loss for the period during which such expenses are incurred.
- 8.3 No Fixed Assets have been received by way of non-monetary grants.

9. Cash Payments

9.1 The foundation releases advances and expenses through bearer cheques. These withdrawals are debited to advance or expenses, as the case may be. No payments are made out of cash in hand or recorded in cash book at any stage.

10. Depreciation on tangible assets

- **10.1** Depreciation on fixed assets is calculated on written down value basis using the rates prescribed in rules under Income Tax Act, 1961.
- **10.2** Library books purchased after 1-april-2010 are being fully depreciated in the year of purchase itself considering their nature. Books purchased earlier are being depreciated @10% p.a. Depreciation is not charged in respect of deductions during the year.
- 10.3 Assets costing Rs. 5000 or less each are fully depreciated in the year of purchase.

11. Foreign currency transactions.

- **11.1** Transactions are denominated in foreign currency (such as contribution from foreign countries) are accounted at the exchange rate prevailing on the date of transaction.
- 11.2 There are no foreign currency assets or liabilities.

12. Retirement benefits.

12.1 Liability towards gratuity payable on death/retirement of employees and for accumulated leave encashment benefit to the regular employees, is provided for on accrual basis. The provision is being made in accordance with Government of India rules for calculation of gratuity and leave encashment since FY 2007-08.

13. Employees

13.1. Expenses on Employees' Retirement and Terminal Benefits (Schedule -13) include provision for leave Encashment and Gratuity Liability.



- **13.2**. The Foundation Follows Centrel Government rules mutatis mutandis in respect of salary fixation of regular employees including contract employed and re-employed retired Government servants. The Foundation pays the salary in accordance with Sixth Pay Commission in respect of such employees.
- 14. Meeting of Governing Council was held on 27th November 2013 with the audited account for financial year 2012-13 being approved in that meeting

15. Capital Commitments

15.1 There are no capital commitments

16. Contingent Liability.

16.1 There are no contingent liability.

17. Provision regarding audit fees

17.1 No provision for audit fees or reimbursement of expenses has been made as the audit is conducted on *pro-bono* basis.
